## Scope and Content

The collection consists of 12 deeds pertaining to land transactions of the Shraeder Farm on the Dietrich Estate in the Town of Washington.

## Historical Note

Parcel 21: ALL that track or parcel of land situate in the Town of Washington, Dutchess County, New York, bounded and described as follows:

BEGINNING in the middle of the highway in the north line of the farm now owned by Jacob Schraeder, being the northeast corner of the premises hereby conveyed and running from thence North 86 degrees West 12 chains and 91 links to the line fence;  
thence South 2 ¼ degrees West 30 chains and 69 links to a corner in Round Pond;  
thence South 67 ½ degrees West 2 chains and 44 links to a stake in the Pond;  
thence South 15 ¾ East 5 chains and 57 links to a corner of the fence being the southwest corner of the premises hereby conveyed;  
thence South 86 degrees East 12 chains and 47 links to the middle of the highway; being the southeast corner of the premises hereby conveyed;  
thence along the middle of said highway North 2 ¼ degrees East 6 chains and 33 links;  
thence continuing in the middle of said highway, North 1 degree and 55' East 23 chains and 54 links;  
thence continuing in the middle of said highway, North 10 degrees 50' East 7 chains and 14 links to the place of the beginning.

Being the same premises conveyed by Jacob Schraeder and Susan E. Schraeder, his wife, to Charles F. Dieterich by deed dated February 11<sup>th</sup>, 1895 and recorded in the Dutchess County Clerk's Office on February 14<sup>th</sup>, 1895 in Liber 279 of deeds at page 292.
