Scope and Content

The collection consists of materials predominantly relating to the estate of Isaac Smith.. Most of the documents are related to legal and/or monetary transactions, such as deeds, mortgages, promissory

notes, and relating letters. There are also 8 receipt books belonging to Isaac Smith, Platt Smith, and Philip Smith. The documents were either loose or grouped into 1 of 7 different bundles by an unknown party. The original ribbon tying these bundles together are also present with the documents.

Historical Note

Isaac Smith (1767-1825) lived in the town of Washington, New York. He apprears to have served, at some point in the military, as well a local judge, though the exact dates of either service is unknown. Smith was also moderately wealthy, being able to lend large sums of money, as evident through promissory notes, deeds and mortgages, and various other legal documents. He wife Phebe Smith née Lewis (married on January 28, 1794) appears to have died some time around 1833.
